

Family Service Lincoln: How We Started

- Behavioral Health began contracting with schools in November of 2004.
- Started in two LPS schools
- Have grown to include six surrounding county school districts and 21 LPS school buildings
- Our Staff
 - Started with two full time staff and one intern
 - Current team includes 17 full time staff, one part time staff, and one incoming intern
 - Five interns this previous school year, four stayed on with our staff.
- We are grant funded and school supported.
- Sub Programs:
 - Parent Connect
 - Immigrant/Refugee Students

Our Staff

- Fully and provisionally licensed therapists
- Interns
- Trained in several modalities and therapeutic interventions


Ongoing Services

- Client centered
- Individual, Group, and Family therapy
- Ongoing collaboration with school staff, community resources, and the family

Referral Process

- Initiated by school counselor or social worker
- Need is identified by family or school staff
- Warm call to families to initiate paperwork and ongoing therapy services
- No cost to families and not time limited

Family Service Lincoln



- In 2024
- 639 students were provided therapy services.
- 96% of clients shared that they were satisfied with our services.
- 78% reported that therapy helped them handle daily life within 90 days of starting the program.
- Logged 9,216 hours within 41 schools (LPS and Surrounding Counties)


Ongoing Trends

- More females than males enrolled in services
- Free and Reduced Lunch, Single Parent households
- Referral Source: School Social Worker and School Counselor
- Top reasons for referral
 - School Problems
 - Family/Parenting Problems
 - Anxiety
 - Depression
- Successful closures


