NEBRASKA COMMISSION ON LAW ENFORCEMENT AND CRIMINAL JUSTICE CRIME COMMISSION FUNDING PANEL COMMUNITY-BASED JUVENILE SERVICES AID PROGRAM [CBA]

The Crime Commission Funding Panel convened Tuesday, March 10, 2020 at 10:00a.m. CST at the Lancaster County/City Building, Conference Room 303, 555 S 10th Street, Lincoln, Nebraska 68508. Notice of this meeting was published on February 24, 2020 in the Lincoln Journal Star and on the website.

I. Call to Order

The meeting was called to order at 10:01 a.m. CST by Elaine Menzel, Chair of the Nebraska Coalition for Juvenile Justice.

II. Introductions

Menzel informed the Committee members that Community-based and Enhancement based applications will be discussed during this meeting. Menzel updated the Committee members that she was able to be involved in both of the two earlier stages of the discussions on the applications. Menzel stated that based on her prior discussions and knowledge on those applications, she would support the recommendations provided on the Summary Comment Sheets. Menzel recommended funding the applications as suggested by the Community Planning Subcommittee and the Grant Committee. Menzel apologized for having to leave early and leave the further discussion to the rest of the Committee members.

IV. FY 2020 Community-based Juvenile Services Aid [CB] and [EB]

Hoffman provided a brief overview on the FY2020 Community-based Juvenile Services Aid Program [CB] and FY2020 Juvenile Services Aid Enhancement Program [EB]. Hoffman reminded the Committee members that she has sent all the materials to all of the members prior to this meeting. Hoffman informed the Committee members that all of these grants were reviewed on February 6, February 7 and February 20th. Hoffman indicated that this will be the third and final review on these grants applications. Hoffman informed that 36 Community-based Aid applications were received and recommended full funding for 35 of them. Hoffman indicated that one applicant is not eligible. Hoffman informed the Committee members that 11 Enhancement applications were received and recommended that nine of them be fully or partly funded.

Discussion ensued among the Committee members on the following CB grants: 20-CB-0535, Urban League and 20-CB-532 Custer County. Hoffman stated that a majority of contingencies for FY2020 funding are related to data and evaluation issues. Discussion ensued among the Committee members on the following denied or reduced EB grants: 20-EB-0600 Platte County, 20-EB-0605 York County, 20-EB-608 Jefferson County, 20-EB-609 Lincoln County.

A motion was made by Dun and seconded by Norris to accept the recommendations as set forth by the Staff Review and Grant Review teams. Voting in favor of the motion: Norris, Dun. Motion carried.
