Drug Evaluation and Classification Program Nebraska Drug Recognition Expert Instructor

Application

The DRE Instructor is an important part of the Drug Evaluation and Classification Program. DRE Instructors are responsible for teaching in DRE Schools as well as observing, evaluating, and verifying the performance of candidate DRE's and witnessing evaluations for certified DRE Officers as required for DRE recertification.

Because of the highly technical nature of the functions performed by the Drug Recognition Expert, only persons experienced in the techniques of drug evaluation should instruct in the Drug Evaluation and Classification Program. In general, these instructors will be certified Drug Recognition Experts with experience in performing drug evaluations, and in providing testimony in court. Dedicated, qualified instructors are critical to the continued success of the Drug Evaluation and Classification Program.

To be considered for DRE Instructor training, the applicant must meet the following criteria.

- Must be a current Drug Recognition Expert in good standing
- Minimum of one year of experience as a certified DRE
- Shall have conducted at least 20 enforcement evaluations
- Must be approved by immediate supervisor and the head of the agency to attend IDC
- Must complete 8 hours of instruction at next DRE School and observe no less than 4 evaluations during the field certification of the DRE School
- Must provide a letter of recommendation from a current Drug Recognition Expert Instructor
- Must provide a letter of recommendation from a Prosecutor
- Must provide a copy of their DRE rolling log and updated CV

To maintain Instructor Status once certified:

A DRE Instructor **must** have 8 hours of instruction time in either ARIDE or DRE School since their last certification and observe 4 evaluations during the field certification phase of the DRE School.
