Graduates receive a certificate of completion recognizing successful participation in a structured instructor development program led by Homefront Protective Group.

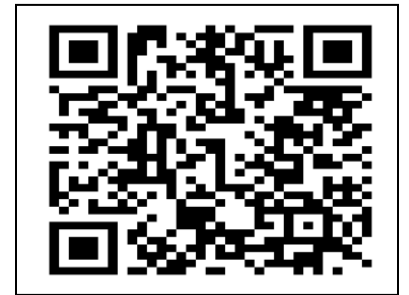
