REGULAR MEETING OF THE POLICE STANDARDS ADVISORY COUNCIL June 15, 2022

#### I. CALL TO ORDER

Chairman, Sheriff Osmond called the meeting to order at 9:00 A.M. Legal notice of the meeting was published in the Lincoln Journal Star on June 1, 2022. Roll call; Sheriff Dan Osmond, Sergeant Drew Bolzer, Lieutenant Colonel Buck Duis, Chief Mark Hogue, Assistant Chief Brian Jackson, Chief Deputy Greg London, Chief Tracy Wolf.

Absent from call to order were Captain Sherie Thomas and Mr. Matthew McCarthy. Mr. McCarthy arrived for the meeting after the approval of the May 18, 2022 minutes.

#### II. APPROVAL OF MAY 18, 2022 P.S.A.C. MINUTES

Chairman Osmond asked if there was a motion for approval of the May 18, 2022 minutes.

#### MOTION

Chief Wolf motioned to approve the minutes. Chief Hogue seconded the motion. Voting in favor; Sheriff Osmond, Sgt. Bolzer, Lt. Col. Duis, Chief Hogue, Asst. Chief Jackson, Chief Deputy London, Chief Wolf. Motion carried.

#### III. REPORTS

#### A. Director-N.L.E.T.C.

Director Urbanek reported that she conducted the Omaha Police Department academy inspection and attended the Law Enforcement Memorial ceremony in Grand Island where Dr. Arp was the keynote speaker.

The Rules and Regulations working committee has had a couple of meetings. Chapters 1 and 16 are on the agenda and at least Chapter 3 and 4 will be on the agenda for the July meeting.

There have been 90 slots requested for the August 28, 2022 Basic Training <u>co</u>urse with 15 names submitted at this time.

Crystal Hoffman has left the training center to take a job with the Veteran's Administration and Kay Fielding continues to work on her recovery.

### B. Deputy Director of Training-N.L.E.T.C.

Deputy Director Mark Stephenson reported the 211<sup>th</sup> Basic class is in the 7<sup>th</sup> week of training. The class in completing the skills blocks and will finish up with Patrol Rifle instruction next week.

The NLETC EVOC Instructor course was held May 9-13<sup>th</sup> with 17 students enrolled. The online portion of Management training started June 6<sup>th</sup> with 13 students enrolled and will be completed on June 24<sup>th</sup>.

The Instructor Development course scheduled for June 6-9<sup>th</sup> and a Knife Defense Instructor course scheduled for June 7-9<sup>th</sup> were both cancelled due to lack of enrollment.

During the May PSAC meeting, Mr. Stephenson was at the IADELST Conference and has made some contacts with other academy training directors.

The Investigative Instructor position has interviews scheduled for June 21<sup>st</sup>.

Mr. Stephenson presented two options for the Reciprocity study guide. The first version is a more comprehensive format with all of the details and the second option is more abbreviated with just the tasks and learning objectives. Mr. Stephenson was looking for the council to review the two options and to let him know which format they would like to see used in the study guide. Director Urbanek asked if the information in the draft study guide came from the lesson plans for the Reciprocity program. Mr. Stephenson responded that all of the information came from the lesson plans and the handouts given to basic students.

Chief Deputy London asked if Mr. Stephenson has a recommendation for which version he preferred. Mr. Stephenson that the short version would be the one he recommends.

Mr. Stephenson stated that reciprocity students have already had the comprehensive training of the material so the study guide would be better in the short form and more Nebraska specific.

Asst. Chief Jackson asked if the student could choose between the short or long version. Mr. Stephenson responded that it would take more time to develop two separate versions of the study guide.

Director Urbanek voiced her concern on having the long version content online that anyone will have access to eventually. She also voiced concern for the long version being taken out of context with the full lesson plan could be misconstrued. Chief Deputy London asked which version her preference would be. Director Urbanek responded that the short version was cleaner, easier to control the content and less work for the staff and recommends the short version. Sgt. Bolzer asked if previously there was a study guide for the Reciprocity test and Director Urbanek stated that there wasn't a study guide but if the agency had someone recently go through Basic training they could use those materials.

Sgt. Bolzer asked what defines a study guide. In his opinion do we need to have more information than "here are the things you are going to be tested on"?

Chairman Osmond recommended that Mr. Stephenson develops the short version of the study guide. Director Urbanek said they would have the full study guide at the next PSAC to take action on approving or not approving it.

### C. Nebraska State Patrol Training Academy

Captain Miller reported that the State Patrol has finished the selection process for Camp 66 and they will begin on July 5, 2022 with 19 recruits.

### D. SDLEA Law Enforcement Academy

Scott Wagner reported that they just completed a class and are prepping for the next course to begin July 5<sup>th</sup> with a graduation date of November 18<sup>th</sup>.

### E. Crime Commission Report

There was no one present from the Crime Commission. There was no report.

### IV. OLD BUSINESS

### A. Sarpy Douglas Law Enforcement Academy Curriculum Exemption

Mr. Stephenson reported that the NLETC instructors were tasked with conducting a curriculum comparison of the SDLEA TAP defensive tactics program and the PPCT defensive tactics program utilized at NLETC. After completing the review, the instructors found that with the exception of some proprietary terminology and techniques, there was no significant variation from what is instructed at NLETC. The content meets all of the learning objectives. The TAP program does expand on high-level resistance and multi-officer control techniques that are not covered by nor addressed pursuant to any specific job tasks so they were not deemed relevant to the comparison.

Chief Deputy London asked if PPCT wasn't going to be taught any longer at NLETC. Mr. Stephenson responded that the training center would still be teaching PPCT and that he had only been tasked with the curriculum comparison. Then Deputy Chief London asked if SDLEA was going to stop teaching PPCT. Mr. Wagner responded that they would be if the exemption was granted.

Director Urbanek voiced her concern that SDLEA, under Rules and Regs, must teach the same State curriculum as NLETC. The proposed change to Chapter 16 addresses that and would allow SDLEA to be considered a separate academy like OPD, Lincoln and the State Patrol. That currently is not the case. To allow SDLEA to have this exception tends to raise questions about the application of Rules and Regulations. Director Urbanek's concern is that with the policy currently in place doesn't allow SDLEA to deviate from the State curriculum.

Mr. Stolz was asked by Chairman Osmond if he had any input. Mr. Stolz responded that per the current Rules and Regulations there is no language that allow any deviation at this time. The Rules and Regulations are specific and if changes need to be made, they need to be made in the correct way.

Chairman Osmond stated that he thought LB 1241 fixed this. Mr. Stolz replied that it did not. Chairman Osmond asked if 1241 gave the PSAC more interpretation of things. Mr. Stolz responded that 1241 was for Reciprocity.

Mr. McCarthy asked if we were dealing with anything more than just trademark differences between the two programs. Mr. Stephenson responded that the only significant difference is that the TAP program expands on high level resistance and multi-officer control techniques that are not part of PPCT. TAP does meet the current job tasks. Director Urbanek asked if the objectives in the TAP program are the same as what is in the State curriculum. Mr. Stephenson responded that the job tasks are covered but the wording of the objectives is different. Director Urbanek referenced Title 79 Chapter 16 006.05b, "All learning and performance objectives in the State curriculum are being taught in each class topic and are readily identified in lesson plans", and again asked if the objectives were not the same but they did meet the current job tasks.

Sgt. Bolzer stated that the goal of the council was to ensure that if anyone is teaching content that it is at least the minimum standard of NLETC curriculum. If they are teaching the same thing to get the objectives done and the content is comparable is that not the same?

Mr. McCarthy stated that in his opinion they should defer to Mr. Stolz. Director Osmond stated that he was under the opinion at the last meeting that the council was onboard with the exemption if the comparison was good. Mr. McCarthy asked Mr. Stolz what the worst case scenario would be. Mr. Stolz responded that in the short term SDLEA gets what they wanted but in the future if an academy wants to train outside officers but not use the State curriculum they could come back and say that since you made an exemption for SDLEA, you can make one for us. Lt. Col. Duis remarked that he wasn't worried about the future as the council could take the requests on a case by case basis and make those decisions at that time. Mr. Stolz was concerned that if another academy was denied there would be a basis for a law suit.

Director Urbanek mentioned that with the fix to Chapter 16 SDLEA could teach whatever they wanted but that takes time.

Chief Deputy London asked Mr. Wagner that if the exemption was denied would they still teach PPCT and then also teach the TAP program. Mr. Wagner said they would continue to add the TAP that is what they did for the last class to avoid any "training scars" that the students would have when they went back to their agencies.

Mr. Stephenson took exception to the term "training scar" and mentioned that since Douglas Co. uses Krav, doesn't that also create "training scars"? If you are going to use the comparison and say that PPCT and TAP are similar but then mention "training scars" that gives the council the impression that they are two different programs.

Mr. Wagner admitted that might not be the best term but continuity in the training is what was important and that Douglas Co. would be using the TAP program if it is approved by the council. Director Urbanek offered that the students that come to NLETC have the same issues. They are taught PPCT but their respective agencies might use controlled force or other programs also.

#### MOTION

Sgt. Bolzer: I make a motion to deny the request based on the Rules and Regs as they stand today. Chief Hogue seconded the motion.

Voting in favor; Sgt. Bolzer, Chief Hogue, Mr. McCarthy. Voting against; Lt. Col. Duis, Asst. Chief Jackson, Chief Wolf, Sheriff Osmond. Abstain; Chief Deputy London. Motion not approved.

Sheriff Osmond asked if there was a different motion.

#### MOTION

Lt. Col. Duis: I make a motion to grant the exemption. Asst. Chief Jackson seconded the motion with discussion.

Asst. Chief Jackson asked if the waiver was a blanket waiver or for a specific period of time since they were looking at changing Chapter 16. Lt. Col. Duis said he could add a time frame to his motion but if the changes to Chapter 16 get held up that could create an issue. Mr. Stolz commented that you could make the motion pending approval of Chapter 16 changes. Chief Deputy London asked Mr. Wagner what he would use for instructors if they lost their TAP certification. Mr. Wagner responded that there are still some PPCT instructors.

#### **AMENDED MOTION**

Lt. Col. Duis: I make a motion to approve the waiver pending approval of Chapter 16. Asst. Chief Jackson seconded the motion.

Voting in favor; Lt. Col. Duis, Asst. Chief Jackson, Chief Wolf, Sheriff Osmond. Voting against; Chief Hogue, Mr. McCarthy, Sgt. Bolzer. Abstain; Chief Deputy London. Motion approved.

### B. LB-1241 Reactivation

Director Urbanek reported 1241 took care of Reciprocity but the Reactivation wasn't addressed. Currently those who were certified in another state only have to take 2 tests to be certified in Nebraska but those that were certified in Nebraska have to take are required to complete a reciprocity course which no longer exists. Mr. Stephenson reported that from 1-30 days there are no training requirements for rehiring, 30 days to 2 years you must complete the handgun qualification and have a valid CPR/First Aid card. From 2-10 years would have to complete the reciprocity course. Mr. Stephenson recommends that those officers that fall in that 2-10 year group should be able to be re-certified by completing the handgun qualification course, completing the physical tasks, and take the reciprocity exam. This would put them on line with Reciprocity officers. More than 10 years inactive would have to go through basic training.

Director Urbanek clarified that they would have the choice of taking the PRET test or completing the physical tasks to make it the same as Reciprocity.

Chief Deputy London asked for example, if an officer from Kansas has been out of law enforcement for 12 years, could he come through Reciprocity. Director Urbanek responded that as long his training was comparable he could.

Asst. Chief Jackson asked if that was something the council had to change. Mr. Stolz commented that 1241 supersedes anything the council did so since they had already set the standards for Reciprocity course so that should cover Reactivation.

Sheriff Osmond asked if there needed to be any action taken by the council. Director Urbanek said that there wasn't any action to be taken. This was just to inform the council that the Reactivation process would now mirror the council approved Reciprocity process. No action was taken by the council.

### V. NEW BUSINESS

### A. One Year Waiver to Attend Basic

Derek White, Rock County Sheriff's Office

Rock County Sheriff James Anderson appeared before the council to address the waiver for Derek White. Sheriff Anderson stated Derek White had COVID during the first go around and didn't get all the paperwork completed for the basic training. Mr. White then failed the PRET test for the next basic. Mr. White was hired August 20, 2021. Sheriff Anderson is requesting a waiver of the one year requirement. The agency does not have many applicants.

Director Urbanek clarified that he didn't complete the 1.5 mile run so the PRET was not scored. You have to complete each component of the test to receive a score. Sheriff Osmond asked if he had retaken the test. Director Urbanek reported that he had not and then she laid out the timeline for Derek White.

Sheriff Osmond asked if Sheriff Anderson thought he would be able to pass the PRET test. Sheriff Anderson responded that he anticipates that Mr. White will complete it.

### MOTION

Chief Deputy London: I make a motion that we grant the waiver with the contingency that he passes the PRET to get into the basic class that starts August 28<sup>th</sup>. However, Mr. White shall not be taking any law enforcement action between from August 28<sup>th</sup> to December 9<sup>th</sup>, 2022. Chief Hogue seconded the motion.

Voting in favor; Chief Hogue, Asst. Chief Jackson, Chief Deputy London, Mr. McCarthy, Chief Wolf, Sheriff Osmond, Sgt. Bolzer, Lt. Col. Duis. Motion approved.

### B. Waiver of one year requirement for Supervision

1. Craig Haverty, Bellevue Police Department

Director Urbanek reported that Craig Haverty was promoted to a Supervisory rank August 15, 2021. (Note from Steve Gobel: That was one day before the 2021 Supervision course started.) Director Urbanek recommends granting the waiver.

#### MOTION

Mr. McCarthy: I make the motion to approve the waiver for Craig Haverty for Supervision. Sgt. Bolzer seconded the motion.

Voting in favor; Asst. Chief Jackson, Chief Deputy London, Mr. McCarthy, Chief Wolf, Sheriff Osmond, Sgt. Bolzer, Lt. Col. Duis, Chief Hogue. Motion approved.

2. Gerald Schumacher, Otoe County Sheriff's Office

Director Urbanek reported that Gerald Schumacher was promoted to a Supervisory rank August 8, 2021. Director Urbanek recommends granting the waiver.

#### MOTION

Chief Wolf: I make a motion to approve the waiver for Gerald Schumacher for Supervision. Mr. McCarthy seconded the motion.

Voting in favor; Chief Deputy London, Mr. McCarthy, Chief Wolf, Sheriff Osmond, Sgt. Bolzer, Lt. Col. Duis, Chief Hogue, Asst. Chief Jackson. Motion approved.

#### C. In-Lieu of Firearms Instructor

Jose Barboza, Sidney Police Department

Chief Joseph Aiken from the Sidney Police Department is asking that Jose Barboza's Colorado Firearms Instructor certificate to be recognized in Nebraska so he can be used as a firearms instructor for the Sidney Police Department.

Director Urbanek reported that Officer Barboza submitted documentation of the Colorado course to Wyatt Hoagland the lead firearms instructor at NLETC. After review, Mr. Hoagland recommends that the Colorado course be recognized. However, when Officer Barboza comes out for his apprenticeship he will need to attend a night shoot as that component was not part of the Colorado curriculum. Per Title 79 Chapter 11, Director Urbanek recommends the approval of the request for Officer Barboza.

#### <u>MOTION</u>

Chief Deputy London: I make a motion to approve the request. Chief Hogue seconded the motion.

Voting in favor; Mr. McCarthy, Chief Wolf, Sheriff Osmond, Sgt. Bolzer, Lt. Col Duis, Chief Hogue, Asst. Chief Jackson, Chief Deputy London. Motion approved.

#### **D.** Medical Waiver for Completion of In-Lieu of Training Kerrion Faulkner, Dodge County Sheriff's Office

Dodge County Sheriff Robert Reynolds appeared on behalf of Kerrion Faulkner. Sheriff Reynolds reported that he was asking for a medical waiver for Kerrion Faulkner. Mr. Faulkner was enrolled in the January Reciprocity course and was injured going over the wall during the physical task testing. Mr. Faulkner's doctor is recommending that he should not try the wall in case he would be reinjured. Sgt. Bolzer asked if he would be able to take the PRET test instead of the physical tasks. Director Urbanek responded that he was pre 1214 and he didn't have to complete the PRET test. The Dodge Co. Sheriff was offered the option of having Mr. Faulkner attend the July PRET test to give Mr. Faulkner some more time to recover from the surgery. Mr. Faulkner does have full medical clearance. Sheriff Osmond asked if the council had the authority to waive the requirement. Mr. Stolz confirmed that the council did not have the authority to waive the requirement.

#### **MOTION**

Sgt. Bolzer: I make a motion to deny the request for the waiver. Chief Hogue seconded the motion.

Voting in favor; Chief Wolf, Sheriff Osmond, Sgt. Bolzer, Lt. Col. Duis, Chief Hogue, Asst. Chief Jackson, Chief Deputy London, Mr. McCarthy. Motion approved.

#### E. Annual Academy Inspection

Omaha Police Department

Director Urbanek reported that for all of the academy inspections this year she is auditing the class on de-escalation. De-escalation has been part of the curriculum for 10 years. On May 19, 2022 Director Urbanek conducted the Omaha Police Department inspection and audited their class on de-escalation. Omaha Police Academy currently has 2 classes going on at the same time. One is a lateral officer course and the other is for new officers. The instructor Jason Cvitanov did an outstanding job. The OPD curriculum has 792 hours of content. Director Urbanek was able to locate all of the job tasks that are required for certification. Director Urbanek reviewed 3 personnel files of the students attending. Based on the inspection, Director Urbanek recommended approval of the annual inspection.

#### **MOTION**

Mr. McCarthy: I make the motion to approve the Omaha Police Department academy inspection for 2022. Chief Wolf seconded the motion.

Voting in favor; Sheriff Osmond, Sgt. Bolzer, Lt. Col. Duis, Chief Hogue, Asst. Chief Jackson, Chief Deputy London, Mr. McCarthy, Chief Wolf. Motion approved.

## F. Firearms Instructor Curriculum Approval

Nebraska State Patrol

Mr. Stephenson reported that Wyatt Hoagland received and reviewed the curriculum for the Nebraska State Patrol Firearms and Patrol Rifle Instructor courses. The courses meet the State of Nebraska instructor standards and Mr. Stephenson recommends approval of the Firearms Instructor and Patrol Rifle Instructor curriculum for 2022.

### <u>MOTION</u>

Chief Wolf: I make a motion for approval. Chief Hogue seconded the motion.
