## **K9 Waiver of Liability**

During this training, I understand that I may deploy with the Omaha Police Department's K9 unit. I further understand that participation in this training and/or the deployments are activities that may be physically dynamic or hazardous in nature.

In consideration of my participation in Police Service Dog Training being held by the Omaha Police Department and/or a deployment, I hereby forever release and covenant not to sue the City of Omaha, the Omaha Police Department, any of their employees and instructors, from any and all present and future claims arising as a result of me participating in any and all training and deployments, that I participate in or any activities incidentally related thereto, wherever, whenever, or however the same may occur. I hereby voluntarily waive all claims both present and future, resulting that be made by me, my family, estate, heirs, or assigns, and I relinquish on behalf of myself, spouse, heirs, estate and assigns the right to recover for injury or death.

I am also aware that I am only able to participate in training and deployments while serving as an active law enforcement officer, while on duty, and with the knowledge and permission of my department. My department's work comp guidelines shall be followed at all times during my involvement with the Omaha Police Department's K9 Unit.
