## **DOMESTIC ABUSE REPORT (2019)**

In compliance with Nebraska State Statute 42-930, law enforcement agencies in the State of Nebraska are required to document and submit the number of domestic abuse incidents that were reported within their jurisdiction each month. The Nebraska Commission on Law Enforcement and Criminal Justice compiles the data from these monthly reports and submits an annual report indicating the total number of domestic abuse incidents reported by each agency.

For the purpose of this report, the following terms have been defined:

**AGGRAVATED ASSAULT:** An unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. This type of assault is usually accompanied by the use of a weapon by means likely to produce death or great bodily harm.

**SIMPLE ASSAULT:** Includes all assaults which do not involve the use of a firearm, knife, cutting instrument, or other dangerous weapon and in which the victim did not sustain serious or aggravated injuries.

**DOMESTIC** applies to family or household members and includes: Spouses or former spouses, children, persons who are presently residing together or who have resided together in the past, persons who have a child in common whether they have been married or have lived together at any time, other persons who are related by consanguinity or affinity, and persons who are presently involved in a dating relationship with each other or who have been involved in a dating relationship with each other.

**ARREST OR EXCEPTIONAL MEANS** refers to the number of incidents that were cleared by law enforcement, and the manner in which the incidents were cleared. An arrest, in this case, refers to the clearance of an incident through law enforcement placing the suspect(s) into custody or a citation/ticket was issued by the responding agency. Exceptional means refers to the clearance of a case when law enforcement have definitively established the identity and location of the suspect, have probable cause supporting the arresting/charging/prosecution of the suspect, however there are reasons outside the control of the law enforcement agency that prevent a custodial arrest from being made or a citation from being issued.
