2.0% INCREASE IN CRIME IN 2016

The number of crimes reported to Nebraska law enforcement agencies has increased 2.0% in 2016 compared to 2015. There were 47,560 crimes reported during January through December of 2016, compared to 46,632 reported during the same period of 2015, an increase of 928 crimes. These numbers include only the crimes of Murder-Manslaughter, Forcible Rape, Robbery, Aggravated Assault, Burglary, Larceny-Theft, Motor Vehicle Theft, and Arson which serve as the *Crime Index* used to measure crime statewide.

Violent crimes (Murder-Manslaughter, Forcible Rape, Robbery, and Aggravated Assault) increased 8.4%. There were 5,193 violent crimes reported in 2016 compared to 4,791 reported in 2015, an increase of 402 crimes.

Property crimes (Burglary, Larceny-Theft, Motor Vehicle Theft, and Arson) increased 1.3%. There were 42,367 property crimes reported in 2016 compared to 41,841 reported in 2015, an increase of 526 crimes.

The following Population Groups saw changes in their crime rates for 2016 compared to 2015: 400,000 & over increased 3.9%; 250,000 to 399,999 decreased 3.4%; 5,000 to 99,999 increased 3.7%; Under 5,000 increased 4.1% and Counties increased 0.1%. State Properties had an increased in their crime rates from 2015 to 2016 by 20.8%.

Total Arrests Increased 1.1% in 2016

The total number of persons arrested in Nebraska during 2016 increased from 70,706 in 2015 to 71,478in 2016, an increase of 772 arrests. The top five categories in terms of the number of arrests made for specific crimes were: Driving Under the Influence (7,425 arrests), Drug Abuse Violations (12,415), Liquor Law Violations (5,217), Larceny-Theft (9,138), and Simple Assault (8,439). The total number of adult arrests (age 18 and over) increased 2.5%, from 65,511 in 2015 to 62,015 in 2016. The total number of juvenile arrests decreased 7.2%, from 10,195 in 2015 to 9,463 in 2016.

A REVIEW OF HATE CRIMES IN NEBRASKA

With the passage of Legislative Bill 90 in 1997, commonly referred to as the Hate Crime Bill, the Crime Commission developed a system for reporting hate crimes. Law enforcement agencies voluntarily submit quarterly reports to the Commission on the number of hate crime incidents. If a hate crime has been committed, they report the type of crime committed a general description of the location, and the type of bias motivation.

During 2016, there were a total of 26 incidents reported from 17 agencies involving crimes motivated by hate. There were 19 incidents reported from 3 agencies in 2015. The types of bias motivation are provided below.
