# 1. Preface

## 1.1. Purpose

The purpose of this Developer's Guide Release Notes document is to provide a summary of the updates to Web Service interface IEPD documents.

## 1.2. Intended Audience

This document is intended for use by application developers that will be developing the “**Client Application**” for **Nebraska Crime Commission (NCC) - Jail Data Exchange (NCJISDEx)**.

## 1.3. IEPD and Content

The **Information Exchange Package Documentation (IEPD)** package contains:

- A collection of XML and XSD files that makeup the data exchange schemas, the complete definition of an Information Exchange Package (IEP)
- And documentation for understanding the business context and usage.

Following is a summary of description of the package content (files and folders):

File/folder	Description
<b>NE Jail Data Business Rule Matrix.xlsx</b>	Document to aid in understanding of the business context and usage.
<b>NE Jail Data Integration Web Service Specification v5.0.pdf</b>	Web Service Specification document describing the Web Service detail information and usage for implementing and maintaining the Client application to submit jail information.
<b>XSD (Folder)</b>	“XSD” Schema folder containing a collection of XML and XSD files that makeup the entire data exchange schemas, a complete definition of an Information Exchange Package (IEP).
<b>Sample_Files (Folder)</b>	Sample xml booking files in accordance with the schema. Typically, it is the client application output to be sent to the NCJISDEx Service.
<b>NCJISDEx_Client_App_Sample (Folder)</b>	Jail Data Exchange client TEST application to connect and submit xml data file to NCJISDEx service. PS. TEST ONLY APP, NOT TO BE USED IN PRODUCTION. Read the application readme file before using.
<b>NCJISDEx_ClientApp (Folder)</b>	Nebraska.JailData.Exchange.Client application for submission testing
