## **Introduction**

The Crime Commission surveys law enforcement agencies each year on the number of sworn and civilian personnel employed as of October 31st. In 2014 the survey covered full and part-time sworn and civilian employees as well as understaffing information. The survey also gathered information on agencies that had contractual agreements with communities or other entities to provide law enforcement coverage. 185 agencies responded to the 2014 survey. **The survey does not include personnel who are paid out of a separate jail budget.**

- 3,654 full-time sworn officers with 79 vacant positions.
  - 1,076 officers employed full-time in Sheriffs' departments.
  - 2,028 officers employed full-time in Police departments.
  - 520 officers employed full-time in State Agencies
- 2.0 full-time sworn officers per 1,000 population (based upon a population of 1,873,414).
- 300 part-time sworn officers with 15 vacant positions.

#### **Civilian Personnel**

- 1,475 full-time civilian employees.
- 300 part-time civilian employees.
- 49 vacant positions (both full-time and part-time).

### **Reserve Officers**

- 62 reserve officers.
- 19% of the total agencies use reserve officers.
