► BEHAVIORAL SCIENCE DIVISION

TITLE: THREAT ASSESSMENT (DAY 1)

Description (Day 1): Regarding pre-attack information, the Behavioral Science Division (BSD) will present Threat Assessment investigation as a tool to prevent mass casualty events. The discussions will include current research, the goals of threat assessment, and the risk factors of attackers. Also included is an analysis of mitigation, mobilization, and motivations of attackers. Case studies will be presented as examples.

Complementing the case studies will be the definition and description of crisis intervention teams, threat assessment teams, and behavioral intervention teams. This presentation will include information on what these teams are, how they are comprised, and what they do.

TITLE: INVESTIGATION OF MASS ATTACKS: AN EXPLORATION IN MANAGING AND CONDUCTING HIGH VOLUMES OF INTERVIEWS (DAY 2)

Description (Day 2): Regarding post-attack, the BSD will present on investigative response to mass casualty events. This presentation will address the logistical complexity of managing and conducting high volumes of interviews associated with mass casualty events. Topics include a scalable investigative response, and reciprocal agreements. BSD will also review an investigative guide created to assist an investigator with managing and triaging these interviews. We will also discuss effective techniques in interviewing victims and witness after a critical incident, how to handle children who need to be interviewed, and lastly how a mass casualty event can effect first responders with a recognition of trauma and how it affects resiliency.

► COUNTERTERRORISM DIVISION (CTD)

TITLE: PRE-INCIDENT PHYSICAL SECURITY ASSESSMENTS (DAY 1)

Description (Day 1): This presentation will describe how attendees can identify physical security deficiencies and vulnerabilities that may lead to an active shooter entering a facility undetected or undeterred. Additionally, it will identify mitigation strategies that will allow for early detection and/or delay of the threat, thus, allowing additional time for first responders to arrive.

The focus will be on open source tools and websites that are available to assist law enforcement in support of this process. Mobile phone extractions, along with CCTV video, produce a wealth of information. FLETC CYD will discuss some of the tips and techniques of capturing that evidence from mobile phones and CCTV systems.

In this presentation, Forensics and Special Investigative Skills instructors will immerse participants within a mass casualty scene containing elements and circumstances encountered at several previous mass casualty incidents. Throughout this interactive experience, instructors will facilitate a discussion of the unique challenges these scenes present, and identify planning and preparation options available to departments to increase their readiness to effectively manage the forensic investigation should a mass casualty incident arise.
