# Requirements for Nebraska Jail Data Reporting - Version 1.3F

- This is the Nebraska specification for jail data submission to VINE/Appriss and the Crime Commission. If the selected vendor already submits data to Appriss in another format then their current format could be used, provided it meets the Nebraska data requirements below.
- All records are placed in the JAIL.DAT file that is delivered to the VINE interface machine.
- Any changes or updates to the available data elements listed below should generate a complete set of records with all the elements.
- Don't populate any field (specially State Id, FBI number, SSN) with dummy values like "Unavailable/Unknown/NA/N.A/Not Applicable/None" etc. If the value is unavailable then just populate as spaces
- An "If Available" Requirement does not mean the booking software can omit this field, it must still be present. This indicates to the jail that the field can be blank if that info is not available on the offender.
- Charge codes are also available in Excel spreadsheet form if requested
