Requirements for Nebraska jail data reporting - Version 2.0 Draft

- This is the Nebraska specification for data submission to the Crime Commission for NEVCAP and NCJIS.
- The table below lists the data elements, along with their associated validation rules and cardinality
- Cardinality definition:
 - o 0..1 optional, provided if available, and can have no more than one occurrence
 - o 1..1 mandatory, required to be provided, and can have no more than one occurrence
 - o 0..* optional, provided if available, and can have more than one occurrence
 - 1..* mandatory, at least one occurrence required to be provided, and can have more than one occurrence
- Validation Class definition:
 - Hard/Error Any records not passing these validation rules will not be accepted
 for processing and saved in the NCC Jail data repository. These records will be
 flagged as Rejected and returned to the agency for correction and resubmission.
 - Soft/Warning Any records not passing these validation rules will be accepted
 with warnings and require review and completion by the agency before it can be
 saved in the NCC Jail repository.
