## NIBRS+ Layout

NIBRS+ is a supplemental component to Nebraska NIBRS Reporting

---

### Record Layouts

---

The SMT, PROPDETAIL and ALIAS Table definitions describe new record types.

The other record segments describe additional fields to be added to the end of the already defined segments (in NIBRS Computer Submission Specifications). Not all record/segment types have additional fields; those that do not are so designated.

The pipe character and the new segment type (for SMT, PROPDETAIL and ALIAS) will be used to filter the NIBRS+ file into the necessary NIBRS file for standard NIBRS processing. (there are no additional fields for Level 2 and Level 3) All items should be treated as fixed length.

No new fields need to be added to the RMS to submit NIBRS+. Data should be inserted as available. There are no new data checks required; data should be supplied as available.

However, for fields for which there are no values they should be left blank (spaces). The NIBRS+ filter program will assume fixed length fields.

Numeric fields are to be right justified.

Alphanumeric characters are left justified.

Address information can be segmented into the separate fields or written to ADDRESS 2.

There may be instances where information collected locally does not exactly match the layout.

It is intended that items are matched as closely as possible and in the form that would be seen as most useful.

Some items may be concatenated or consolidated for NIBRS (such as some property) and NIBRS rules should always be given priority.

The additional information in NIBRS+ will be used for law enforcement purposes.
