Standardized Field Sobriety Testing

Instructor Development Course Application

Phase I: Consists of 40 hours of classroom training. This training will develop effective trainers who will be able to instruct law enforcement officers on a regular basis. Participants will become familiar with content, learning activities, and training aids related to delivery of the Standardized Field Sobriety Testing Courses. Participants will be required to pass a written examination with a minimum 80% to move on to Phase II.

Phase II: After participants have completed the classroom training of the IDC course, **they are required to teach at a basic academy class with an experienced Instructor(NLETC or SDLEA). They must be able to demonstrate the ability to effectively communicate, demonstrate and instruct recruit officers.** After the course is completed, they can become certified as a SFST Instructor in the State of Nebraska.

To maintain Instructor Status:

A certified SFST Instructor **must** instruct at least one 8-hour session in a Basic SFST Course ***every two years***.
