REGULAR MEETING OF THE POLICE STANDARDS ADVISORY COUNCIL November 20, 2024

I. CALL TO ORDER

Chairman, Sgt. Drew Bolzer called the meeting to order at 9:00 A.M. Legal notice of the meeting was published in the Lincoln Journal Star on November 13, 2024. Roll call; Sgt. Drew Bolzer, Chief Paul Graham, Chief Deputy Greg London, Mr. Matthew McCarthy, Chief Steve Reeves, Asst. Chief Jason Stille, Deputy Chief Sherie Thomas. Lt. Col. Buck Duis and Sheriff Dan Osmond were absent.

II. APPROVAL OF October 16, 2024 P.S.A.C. MINUTES

Sgt. Bolzer asked if there was a motion to approve the October 16, 2024 minutes.

MOTION

Chief Graham: I'll make a motion to approve the minutes. Mr. McCarthy seconded the motion.

III. REPORTS

A. Director's Report

Director Mark Stephenson reported on the following:

• The process to hire additional instructional staff is moving forward. The process is currently with NAPE. Pay increases are being asked for to encourage recruitment and also retention of the current staff.

- The ARPA project is moving forward. The only change in the plan at this time is the removal of the indoor firing range. All other elements of the plan will remain the same.
- NLETC is gathering statistics for the new initiative from the Governor's
 office. The numbers will reflect the level of support, the amount of work
 and the number of ways NLETC supports law enforcement in the State of
 Nebraska. The stats will be presented at the December meeting.
- Academy Audits: Academy inspection notifications were sent out on October 15, 2024 with a due date of November 4, 2024. There were no on-site inspections this year due to recent changes in the process and a new compliance coordinator. NLETC is working with the academies to correct the following discrepancies were found in one or more agencies;
 - Discrepancies with the academies list of certified instructors compared to the NLETC list.
 - o Physical tasks not tested or not listed as tested.
 - o Missing background reports and medical reports.
 - o No proof of AFIS search.
- Annual Reporting; (as of October 3, 2024)
 - Continuing Education-98% of agencies were reporting under 50% of officers had completed the requirements.
 - Firearms Qualification-76% of agencies were reporting under 50% of officers had completed the required qualification.
- As of November 1, 2024 (after a reminder email that was sent October 4, 2024):
 - o Continuing Education-94% of agencies were reporting under 50% of officers had completed the requirements.
 - Firearms Qualification-56% of agencies were reporting under 50% of officers had completed the required qualification.

Another reminder email was sent November 2, 2024,

• 30 applications have been received for the January 6, 2025 class. 20 applications are complete and 10 are still in the process of completion. The application deadline is December 6, 2024.

Sgt. Bolzer asked if anything had been reported on LB 51. Director Stephenson reported that he has seen the initial proposal and there are some considerations for changes to continuing education hours.

B. Deputy Director's Report

Deputy Director Gene Boner reported on the following:

- The 218th Basic currently has 40 students enrolled. Currently in week 13 of training.
- The following training was held at NLETC:
 - o Field Training Officer-October 28-November 1: 16 students
 - o Traffic Crash Reconstruction-October 28-November 8: 12 students
 - o Online Management-October 28-November 15: 14 students
 - o Firearms Instructor Recertification-November 4: 9 students
 - o Patrol Rifle Instructor Recertification-November 5: 5 students
- While Deputy Director Boner is on medical leave, instructor Wyatt Hoagland will be taking care of the day to day duties.

Agency Counsel David Stolz entered one exhibit. Exhibit 1 is the Consent to Revocation of Law Enforcement Certificate and Waiver of Notice and Hearing for Andrew Bremer. Sgt. Bolzer accepted the exhibit, and it was entered into the record.

Mr. Stolz provided the factual summary of the details leading up to the revocation. Mr. Stolz asked that the Council accept the relinquishment and recommends to the Commission that Andrew Bremer's law enforcement certificate, management certificate, and supervision certificate be revoked based on the violation of his code of ethics as well his statutory duties set out in Nebraska Revised Statute 81-1403 Section (6)(c).

MOTION

Chief Deputy London: Based upon the fact that the respondent has signed a Consent to Revocation of Law Enforcement Certificate and Waiver of Notice and Hearing and has voluntarily surrendered his or her certificates, those are the Nebraska Law Enforcement Certificate, Management Certificate, and Supervision Certificate, I make a motion that the Council accept the surrender of Adam Bremer's three certificate based on the recommendation outlined by Counsel David Stolz. Said revocation to be effective upon review and acceptance of the surrender by the Nebraska Crime Commission on Law Enforcement and Criminal Justice. Chief Graham seconded the motion.

DISCUSSION

Jessica Wagoner asked if Chief Deputy London would need to amend his motion since he said Adam Bremer instead of Andrew Bremer.

AMENDED MOTION

Chief Deputy London: So amended. Chief Graham seconded the amended motion.

2. Jacob Wasser: LR-275-24

Agency Counsel David Stolz entered one exhibit. Exhibit 1 is the Consent to Revocation of Law Enforcement Certificate and Waiver of Notice and Hearing for Jacob Wasser. Sgt. Bolzer accepted the exhibit, and it was entered into the record.

Mr. Stolz provided the factual summary of the details leading up to the revocation. Mr. Stolz asked that the Council accept the relinquishment and recommends to the Commission that Jacob Wasser's law enforcement certificate be revoked for violation of his statutory duties and code of ethics per Nebraska Revised Statute 81-1403, Section (6)(c).

<u>MOTION</u>

Asst. Chief Stille: Based upon the fact that the respondent has signed a Consent to Revocation of Law Enforcement Certificate and Waiver of Notice and Hearing and has voluntarily surrendered his certificate, I make a motion that the Council accept the surrender of Jacob Wasser's Nebraska Law Enforcement certificate based on the recommendation outlined by Counsel David Stolz. Said revocation to be effective upon the review and acceptance of the surrender by the Nebraska

Commission on Law Enforcement and Criminal Justice. Chief Reeves seconded the motion.

Voting in favor: Mr. McCarthy, Chief Reeves, Asst. Chief Stille, Deputy Chief Thomas, Sgt. Bolzer, Chief Graham, Chief Deputy London. Motion approved.
