#### COMMISSION ON LAW ENFORCEMENT AND CRIMINAL JUSTICEREGULAR MEETING OF THE POLICE STANDARDS ADVISORY COUNCIL February 21, 2024

#### I. CALL TO ORDER

Chairman, Sergeant Drew Bolzer called the meeting to order at 9:00 A.M. Legal notice of the meeting was published in the Lincoln Journal Star on February 15, 2024. Roll call; Sgt. Drew Bolzer, Chief Paul Graham, Asst. Chief Brian Jackson, Chief Deputy Greg London, Mr. Matt McCarthy, Sheriff Dan Osmond, Chief Steve Reeves, Deputy Chief Sherie Thomas. Lt. Col. Buck Duis was absent from the meeting.

#### II. APPROVAL OF JANUARY 17, 2024 P.S.A.C. MINUTES

Sgt. Bolzer asked if there was a motion to approve the January minutes.

#### MOTION

Asst. Chief Jackson: I would make a motion to approve the January 2024 PSAC minutes. Mr. McCarthy seconded the motion.

Voting in favor: Chief Graham, Asst. Chief Jackson, Chief Deputy London, Mr. McCarthy, Sheriff Osmond, Chief Reeves, Deputy Chief Thomas, Sgt. Bolzer. Motion approved.

#### III. REPORTS

#### A. Director's Report

Director Stephenson reported that he has started a discussion with the other academies and agencies regarding requests to hold their own Supervision courses. The guideline has been that we would compare the suggested curriculum from an agency wanting to conduct their own course to the schedules for the last few NLETC Supervision courses. Director Stephenson has come up with four core topics for both Supervision and Management. The core topics would be for a recommended but not mandated amount of time. There would be a minimum number of set hours for Supervision and Management. Agencies could base their own Supervision and Management courses on the core topics and minimum hours that are set by NLETC and then could expand their individual courses to cover agency specific and other topics. This would provide consistency for an agency requesting to conduct their own courses. It would also

present this as an agenda item at the March meeting for approval. The Supervision core topics are; standards of performance/supervising marginal or problem employees, ethics, followership/mentorship, and legal issues for supervisors. The Management core topics are background investigations, fiscal resources, leadership, and law enforcement and the media.

Asst. Chief Jackson stated that he liked sending people to NLETC for Supervision and Management as the students could network with people from different agencies. If individual agencies just started holding their own courses the agencies could become isolated from other agencies. Director Stephenson responded that if the agencies requesting to hold Supervision and Management opened up registrations to other agencies that would address the situation.

Chief Deputy London commented that they planned on letting the other SDLEA agencies attend their requested Supervision course.

Director Stephenson reported on the Academy Application quick reference guide that has been posted on the NLETC website. The next quick reference guide that will be posted will be on the appeals process.

Administrative Technician Wendy Bueno Rodriguez will be leaving the Training Center. She was hired as a temporary employee to assist the standards team. NLETC has hired a full time compliance coordinator who will start February 26<sup>th</sup>.

Sheriff Osmond asked for clarification on the PRET test. He asked if you failed the PRET test at the agency, would you have to redo the test at NLETC. Director Stephenson clarified that he had changed the policy. If you fail the PRET test at the agency you could do the retake at the agency. If an applicant had their application accepted and were deferred to another basic they would not have to redo the PRET test.

#### B. Deputy Director's Report

Deputy Director Boner reported that the 216<sup>th</sup> Basic currently has 46 students enrolled. The class started with 50 students. Two were separated for academic failures, one left due to family and health issues, and one was dismissed for lying to an instructor.

The following training courses were conducted in January and the beginning of February:

- Defensive Tactics Instructor Recertification-January 15-17, 2024: 14 students enrolled
- Field Training Officer-February 12-16, 2024: 25 students enrolled



Two applications have been received for the open Defensive Tactics Instructor position. Interviews are scheduled for February 29, 2024. The SFST coordinator position is still posted.

## C. Nebraska State Patrol Training Academy

Sgt. Nicholas Plate appeared in place of Captain Ecklund. Sgt. Plate reported that Camp 69 currently has 15 recruits. Sgt. Plate reported on the training completed by the recruits and what training was coming up.

## D. Crime Commission Report

Executive Director Tuma reported:

- Congressman Flood sponsored an event in Lincoln called "Back to Blue". The focus of the event was on retention and attracting candidates for employment as law enforcement officers.
- LB-1093 is the bill trying to correct the language of the definition of a law enforcement agency. The bill has come out of committee.
- 9 misconduct cases were referred to the Attorney General's office. Executive Director recommended getting an attorney on staff to handle the misconduct cases. There were 9 cases dismissed at the last Crime Commission meeting. There were a couple of cases where there were criminal convictions that resulted in an automatic revocation of certifications.
- The probation database that is part of the NCJIS platform is in the final stages of beta testing. It will be live soon.
- The expansion project is on track. The ARPA funds have to be spent by December 31, 2026. Dewberry is in the final design phase then the cost estimates will be submitted and then the project will be open for the bidding process.
- Joe Wilcox who has been the Crime Commission's budget analyst is retiring.

Mr. Stolz added that Chapter 8 has been approved by the Attorney General's office. It has been sent to the Governor's office. Five days after the Governor approves it, it will go into law. Asst. Chief Jackson asked about Chapter 10. Mr. Stolz replied that Chapter 10 has been at the Attorney General's office. All of the changes made to Chapter 10 have been put into LB-1093.

## IV. Old Business

## A. Nebraska Revised Statute 81-1462 Hiring Bonus Grant

Director Stephenson reported that NLETC was developing a policy statement to guide the application process and an application to apply for the grant. A copy of the draft was distributed to the Council. Asst. Chief Jackson reported that a small group of Council members met on the 13<sup>th</sup> of February to talk about 81-1462. The meeting was to make recommendations for the policy and practice statement. The total program cost will be 25,000,000 dollars instead of 30,000,000 dollars. The hiring bonus was decreased from 10,000 to 7,500. This could be reviewed annually to adjust if necessary.

## Discussion Points:

- The request must come from the agency.
- Payment will be made to the newly hired officer.
- To qualify as a newly hired officer:
  - Full-time officer at an agency with fewer than 150 full-time officers.
  - Newly certified officer of an approved academy after January 1, 2024.
  - Completion of the reciprocity program after January 1, 2024.
  - Reactivation after January 1, 2024 when more than 2 years in an inactive status.
  - Payment amount \$7,500.00 (payable until funding is exhausted).
  - Indication or attestation from the agency that the hiring bonus will not be used to supplant the salary of the officer.
- Agency would determine when they would apply (upon certification, after field training, or whatever condition the agency sets).
- Recommended staffing level was to be determined by the Council. It was decided that if the agency had the budget to hire an officer they would be under their staffing level. The application would include a place for the agency to justify the reason for the request.
- The applications would be reviewed by the Council for approval or denial.

The application will need to specify the difference between reciprocity and reactivation. Revisions to the policy and procedure and the application will be sent out before the March meeting and will be on the agenda in March for approval.

The Council went into Executive Session at 9:46 a.m.

Sgt. Bolzer called the meeting back to order and asked if there was a motion to come out of executive session.

Deputy Director Boner reported that the individuals listed have requested an extension of the 1-year requirement to attend Supervision. Kreighton Baxter from the Clay Co. Sheriff's office was promoted to Sergeant on June 1, 2023. He was unable to attend the July 2023 NLETC Supervision course. Nicholas Boswell and Brian Mathew of the La Vista Police Department were both promoted to Sergeant in June of 2023 and were unable to attend the course in July of 2023. Brandon Hahn, Aneta Nelson, and Daniel Rubin of the Omaha Police Department were all promoted during the first six months of 2023 and were scheduled to attend the Omaha Supervision course in November 2023. All of the officers except for Brandon Hahn are planning on attending the NLETC course in July 2024. Hahn had a prior commitment for that time period and would attend the first available

Chief Deputy London asked what would happen if they were denied. Mr. Stolz responded that since they would be in violation of State statute they could have their certificate suspended.

## E. Extension of the 1-year Requirement for Management

Deputy Director Boner reported that Brian Gertsch of the Perkins Co. Sheriff's office was promoted to Chief Deputy in September 2023 and was unable to attend the October 2023 NLETC Management course. Charles Hildebrand of the York Co. Sheriff's office was promoted on March 1, 2023 and has completed the in-person portion of management training and is enrolled in the March 2024 on-line course. Chilton Leedom of the Ceresco Police Department was promoted on December 12, 2022 and was unable to complete the course in December 2023. Malychanh Sayaloune of the Dawes County Sheriff's office was promoted to Chief Deputy in September 2023. Deputy Director Boner recommends the approval of all of the extension requests.

Sgt. Bolzer asked if there was a motion.

## MOTION

Chief Graham: I'll make a motion to approve the 1-year extension for management under item V-E so long as they are able to attend the upcoming NLETC course. Sheriff Osmond seconded the motion. Voting in favor: Chief Reeves, Deputy Chief Thomas, Sgt. Bolzer, Chief Graham, Asst. Chief Jackson, Chief Deputy London, Mr. McCarthy, Sheriff Osmond. Motion approved.

### F. Sarpy County Sheriff's Office Request to Conduct Supervision

Deputy Director Boner reported that Sarpy County Sheriff's office has submitted a curriculum and schedule to hold their own Supervision course in-lieu-of the NLETC course. After review, Deputy Director Boner recommended the approval of Sarpy County's request. The curriculum submitted aligned with the NLETC curriculum that has been taught in the last four years.

There was discussion on how long the request would be for. Since the newly proposed program introduced in the Director's report hasn't been approved this would be for 2024 and would need to be voted on again for 2025. Chief Deputy London clarified that all of the agencies that are part of SDLEA could have officers attend the course.

Sgt. Bolzer asked if there was a motion.

#### MOTION

Asst. Chief Jackson: I would make a motion to approve for 2024 the Sarpy County Sheriff's request to conduct supervisory training. Deputy Chief Thomas seconded the motion.

Voting in favor: Deputy Chief Thomas, Sgt. Bolzer, Chief Graham, Asst. Chief Jackson, Mr. McCarthy, Sheriff Osmond, Chief Reeves. Abstained: Chief Deputy London. Motion approved.

#### G. Revocation

Payton Boston (LR-253-23)-Voluntary Surrender

Mr. Stolz entered two exhibits. Exhibit 1 is the Consent to Revocation of Law Enforcement Certificate and notice of waiver of hearing for Payton Boston. Exhibit 2 was the email correspondence between Payton Boston and the Crime Commission. Sgt. Bolzer accepted the exhibits and entered them into the record.

Mr. Stolz gave the factual summary of the details leading up to the revocation. Mr. Stolz asked that the Council accept the relinquishment and recommends that Mr. Boston's Law Enforcement Officer certificate be revoked for violation of his statutory duties and code of ethics per Nebraska Revised Statute 81-1403(6)(c).

Sgt. Bolzer asked if there was a motion.

#### MOTION

Asst. Chief Jackson: Based on the fact that the respondent has signed a Consent to Revocation of Law Enforcement Certificate and waiver of notice and hearing and has voluntarily surrendered his Nebraska Law Enforcement certificate, I make a motion that the Council accept the surrender of Payton Boston's Nebraska Law Enforcement Certificate based on the recommendation outlined by Counsel David Stolz. Said revocation to be effective upon review and acceptance of the surrender by the Nebraska Commission on Law Enforcement and Criminal Justice. Sheriff Osmond seconded the motion.

## DISCUSSION

Sgt. Bolzer asked for clarification if he held a management or supervision certificate. Mr. Stolz verified that he only had the Law Enforcement certificate.
