REGULAR MEETING OF THE POLICE STANDARDS ADVISORY COUNCIL May 17, 2023

I. CALL TO ORDER

Chairman, Assistant Chief Brian Jackson called the meeting to order at 9:00 A.M. Legal notice of the meeting was published in the Lincoln Journal Star on May 10, 2023. Roll call; Asst. Chief Brian Jackson, Sgt. Drew Bolzer, Chief Deputy Greg London, Sheriff Dan Osmond, Deputy Chief Sherie Thomas, Chief Wolf.

Absent from call to order were Lt. Col. Buck Duis and Mr. Matt McCarthy.

II. APPROVAL OF APRIL 19, 2023 P.S.A.C. MINUTES

MOTION

Chief Wolf motioned to approve the minutes of the April 19, 2023 meeting. Deputy Chief Thomas seconded the motion.

Voting in favor; Sgt. Bolzer, Chief Deputy London, Sheriff Osmond, Deputy Chief Thomas, Chief Wolf, Asst. Chief Jackson. Motion carried.

III. REPORTS

A. Director-N.L.E.T.C.

Director Urbanek reported that on May 12th Governor Pillen signed Title 79 Chapters 1, 2, 3, 4, 9, 16 and 17. Making them effective May 17, 2023. They will be posted on the NLETC website and a notice will be posted on NCJIS that they have been updated. Chapter 8 is still at the Governor's office for approval.

Director Urbanek attended the LECC conference in Kearney. Presented to the PCAN that there was a vacancy on the Police Standards Advisory Council for a police chief of an agency serving 5000 or less people.

Director presented the L.E.A.R. process at the LECC conference. The hiring bonuses are on hold until the initial incentive payments have been made. Agency Brenda L Urbanek, Director presented the L.E.A.R. process at the LECC conference. The hiring

Director Urbanek requested clarification from the Council on the definition of a law enforcement agency and if officers working for agencies that are not considered "law enforcement agencies", but are certified law enforcement officers, would they be eligible for the Retention Bonus.

The item will be rolled over to New Business.

Hastings Police Department was the agency selected for the Beta Testing of the L.E.A.R. application process.

Director Urbanek also presented information to the PCAN on Reciprocity and the process to complete the program.

Director Urbanek reported that Mike Kerby will provide an update on the Police Service dog standards at the June PSAC meeting.

There was a pre-design meeting for the construction project. DAS Building division is running the project with NLETC providing specific information on what is needed. Expecting to have some drawings within 30 days.

B. Deputy Director of Training-N.L.E.T.C.

The 214th Basic class started with 50 students on May 1st. Currently in week 3. One student voluntarily withdrew from training and two who were separated for academic failure so currently there are 47 students enrolled.

The following training courses NLETC hosted:

- NCIC training, April 17-19th with 39 attending
- Traffic Crash Reconstruction, May 1-12th with 11 attending
- EVOC Instructor, May 15-19th with 11 attending
- FLETC TAC Med Instructor, May 15-17th with 20 attending
- FLETC TAC Med User, May 18th with 19 attending
- Firearms Instructor Recertification, May 16th with 5 attending
- Patrol Rifle Instructor Recertification, May 17th with 2 attending

C. Nebraska State Patrol Training Academy

Capt. Ecklund reported that Camp 67 is currently in week 19. Currently down to 12 recruits. Guest day is May 19th where the recruits will receive their duty stations and badge numbers. Camp is scheduled to graduate on June 16th. Camp 68 will begin on July 5th.

D. Crime Commission Report

Executive Director Arp was absent from the meeting. There was no report.

Chairperson Jackson moved agenda item I to the first order of business.

V. NEW BUSINESS

I. Reciprocity Program and Process Review

Director Urbanek reported that prior to July 1, 2022 the Reciprocity Program was administered under Title 79 Chapter 3. The newly approved Chapter 3 reflects the statutory changes in LB 1241. Director Urbanek outlined the process before LB 1241. LB 51 that was passed in August 2021 changed it so that a reciprocity officer could not work in a law enforcement capacity until they received Nebraska certification. LB 1241 removed the language that allowed military and federally certified officers to use their training towards Reciprocity. The Council was asked to establish what was to be considered an equivalent curriculum. Director Urbanek outlined the current process for processing Reciprocity students. Initially it was decided to do all of the testing at NLETC until the system was fully developed to be available to satellite testing sites.

Deputy Director Stephenson outlined the current testing procedures for Reciprocity.

Lt. Kenneth Fox, Omaha Police Department, appeared before the Council. Lt. Fox reported that OPD completed its first reciprocity training program with 3 officers completing the course.

Officer Jason Cvitanov, Omaha Police Department, appeared before the Council. Officer Cvitanov reported that LB 124, that passed in 2022, sought to make the Reciprocity process more streamlined to make Nebraska competitive in attracting out of State officers. Officer Cvitanov asked for the Council to consider two items to help streamline the out of state lateral process. First he requested the ability to conduct their own physical testing for reciprocity without having to have anyone from NLETC to come on site. Currently OPD is able to conduct their own physical testing for entrance into the academy and would like the freedom to do so for Reciprocity applicants. Second, the Nebraska Revised Statute Section 81-1414.13(3)(d) requires a reciprocity applicant to pass a test approved by the Council. The Omaha Police Department requests that the Council consider the final exam given at the end of their lateral/reciprocity training academy to be an approved Reciprocity exam. Omaha Police Department has a 440 hour lateral/reciprocity academy.

Sgt. Queno Martinez, Omaha Police Department, asked that the comprehensive test they use to certify the agencies basic recruits should be available to use as the Reciprocity test.

Mr. Stolz clarified that the currently approved test measures the baseline knowledge that the Reciprocity officer knows so that they can go and work as an officer. The other agencies in the state have to complete the current test without having received the 440 hours of training that OPD provides.

Officer James Maguire, Omaha Police Department appeared before the Council. As the State President of the Fraternal Order of Police, the FOP was heavily involved in the LB 51 and LB 1241. Officer Maguire requested that the Council let the academies proctor their own tests. Officer Maguire stated that the comprehensive test given to the lateral students should be the Council approved test for Reciprocity. All academies should have the right to do the same as Omaha Police Department wishes to do.

Sgt. Bolzer stated that he would have no problem with the academies proctoring the current approved test but if all the academies had their own version of the test it would mean that the standards would be different for each academy.

Captain William Rinn from the Douglas County Sheriff's Office wanted clarification on NCO's and if they could work in a law enforcement capacity. Director Urbanek clarified that if an NCO was hired and would be having contact with the public as a law enforcement officer they would need to have the required 80 hours of training in order to do so. Reciprocity officers could be hired as NCO's that would be allowed to do that

Captain Rinn asked if SDLEA was verifying admission packets for the academy. Director Urbanek said that they were not at this time but NLETC was coming up with a process for OPD, Lincoln P.D. and the Nebraska State Patrol for verifying the initial admission packets and that with the Council approval that could be the same for SDLEA. Captain Rinn stated that when that process was approved for basic training they would like to have that same option for Reciprocity applicants.

Captain Rinn requested that SDLEA be allowed to proctor the current reciprocity written test and the physical tests.

Sgt. Daniel Noonan from the Lincoln Police Department also made the request that Lincoln Police Department be allowed to proctor the current reciprocity written and physical tests.

MOTION

Sheriff Osmond: I would make a motion that the academies be allowed to conduct their own PRET or physical skills testing and proctor the approved reciprocity test. Deputy Chief Thomas seconded the motion.

Voting in favor: Chief Deputy London, Sheriff Osmond, Deputy Chief Thomas, Chief Wolf, Asst. Chief Jackson, Sgt. Bolzer. Motion approved.

Asst. Chief Jackson asked if there were any other motions.

MOTION

Sheriff Osmond: I would make a motion that the academies be allowed to conduct their own approved by the Council reciprocity test as the statute states. Deputy Chief Thomas seconded the motion.

DISCUSSION

Council members wanted clarification on what test the motion covered and whether they needed a separate motion for each academy.

AMENDED MOTION

Sheriff Osmond: The motion is that the Omaha Academy can conduct their own reciprocity test based on their certification test. Asst. Chief Jackson seconded the motion.

DISCUSSION

Sgt. Bolzer stated he would be more likely to vote yes if the agencies would be willing to open their reciprocity program to other agencies. Director Urbanek asked if it would help the Council to make a decision if they first saw the test being suggested to determine if it is a comprehensive test. Sgt. Bolzer asked if this motion was needed as the previous motion allowed the academies to proctor the current approved test. Asst. Chief Jackson clarified that Omaha Police Department preferred to use their own comprehensive test.

Voting in favor: Sheriff Osmond, Asst. Chief Jackson, Chief Deputy London. Voting against: Chief Wolf, Sgt. Bolzer. Abstained: Deputy Chief Thomas. Motion carried.

Director Urbanek wanted clarification if the motion passed was effective as of May 17th. Asst. Chief Jackson said it was.

174		statements by yourself. Sheriff Rust or Chief Deputy Mauck, do you have
175		any written evidence for us to consider on behalf of your agency or Ms.
176		Russell?
177	Sheriff:	Yes we do.
178	Mauck:	I have a letter from Brenda. This letter is (unintelligible) the original denial
179		for the second crime of omissions and falsifications was based on
180		information provided by Chief Deputy Mauck provided evidence that Ms.

182		did not understand how to properly complete the box on page 3. I consider

I have other character letters from different people within, the clinical director, the director of Revive Ministries where she has completed the out-patient and continuing as being on the board of directors and she has recently spoke at a function, fundraiser for Revive Ministries and she was one of the speakers on where she had been and where she come to today and she has a great desire to stay sober and stay out of that life style that she wants to leave behind her. We are requesting that you consider the waiver to grant her admission to the academy with her Class 1 Misdemeanor. We

288		to turning my life around and putting in the work to become the best
289		version of myself every day. Learning humility, patience and dedication
290		was the root of my new way of life. I started from square one and
291		completed 30 day inpatient program at Independence Center at Bryan
292		LGH in Lincoln and after that I was all in and never looked back. 100%
293		willing to put in the work to make sure my sobriety stuck. From inpatient I
294		immediately moved to Hastings for the extended care program at Horizon
295		Recovery where I moved into their sober living house. I followed every
296		house rule and became a leader among my peers. After six months and

completing the program I stayed in the house for another six months as	
the house manager. I then moved into my own house and joined the	
mentor program which I am still doing today. A little over a year ago I was	3
asked to join the board which I accepted. It's not just my life's mission to	
stay sober, I grow every day, but also to help encourage others to do so.	
At the end of the month I will also be volunteering at the YRTC in Hasting	JS
teaching young women life skills as part of an eight week series. I have	
also used my time of sobriety to getting to know God and becoming	
involved with my church. I have taken leadership classes with my pastor	
and started a women's bible study. I was also baptized in 2020. I know th	ıe
whole reason that I got the opportunity to really commit to my sobriety wa	ıs
because I got caught and I did not take that lightly. After my license was	
reinstated I did not drive for nearly a year because I wanted to be	
absolutely certain that I was never going back to my old ways. So I rode	
my bike every day in all weather conditions for my transportation. I took	
my rehabilitation very seriously and I didn't' take any easy ways out. I	
have grown so much as a person and I would be extremely honored to pu	ut
all my hard work into action and to be accepted into the training center.

IV. OLD BUSINESS

A. Law Enforcement Attraction and Retention Act (L.E.A.R.)

Mr. Mathis reported that every agency was emailed two files on how to apply. The first was a user name/password login list for getting into our NLETC Learning site so they can complete the applications. They also received a PDF that walks them through the application process. Mr. Mathis showed a computer presentation on the application process and how the information was recorded and disseminated for the payments to be issued.

Assistant Chief Jackson asked if there was a motion to identify the agencies for which an active officer can receive this retention bonus?

Director Urbanek clarified that if the NLETC received a change in status form showing a person as an "Active" law enforcement officer they would be eligible.

There was also discussion on whether the 12 months of employment had to be at one agency.

Assistant Chief Jackson asked if there was a motion.

MOTION

Sheriff Osmond: I would make the motion that any active, full time law enforcement officer receive the retention bonus. That meets the criteria of the statute. Deputy Chief Thomas seconded the motion.

Voting in favor: Sgt. Bolzer, Chief Deputy London, Sheriff Osmond, Deputy Chief Thomas, Chief Wolf, Assistant Chief Jackson. Motion approved.

Asst. Chief Jackson asked if there was anything else that needed clarifying. Director Urbanek wanted clarification on how to proceed with the 12 month rule. Sheriff Osmond said that the Council needed to provide the direction for that.

MOTION

Sheriff Osmond: I would make the motion that retention bonuses paid that you have to be with that office for the year and since it starts in July it would have to be July 1 to June 30 in order to receive that retention bonus. Asst. Chief Jackson seconded the motion.

After discussion Sheriff Osmond amended his motion.

AMENDED MOTION

Sheriff Osmond: I would amend my motion to say, you are eligible for the retention bonus when you have 12 months of continuous employment with the same agency. Subject to statute. Asst. Chief Jackson seconded the motion.

Voting in favor: Chief Deputy London, Sheriff Osmond, Deputy Chief Thomas, Chief Wolf, Asst. Chief Jackson, Sgt. Bolzer. Motion approved.

- V. NEW BUSINESS (continued)
 - A. Revocation of Law Enforcement Certification-Voluntary Surrender
 - 1. Tatum Dobson, LR-248-23

Mr. Stolz entered the Consent to Revocation of Law Enforcement Certificate and notice of waiver of hearing for Tatum Dobson to be entered as Exhibit 1. Asst. Chief Jackson excepted the exhibit and it was entered into the record.

Mr. Stolz gave the factual summary on the details leading up to the revocation. Mr. Stolz asked that the Council except the relinquishment and recommends that Ms. Dobson's law enforcement certificate be revoked.

MOTION

Chief Deputy London: I make a motion that we revoke the law enforcement certification for Tatum Dobson based on the recommendation from counsel. Sheriff Osmond seconded the motion.

Voting in favor: Sheriff Osmond, Deputy Chief Thomas, Chief Wolf, Asst. Chief Jackson, Sgt. Bolzer, Chief Deputy London. Motion approved.

2. Stanley McKnight, LR-242-23

Mr. Stolz entered the Consent to Revocation of Law Enforcement Certificate and notice of waiver of hearing for Stanley McKnight to be entered as Exhibit 1. Asst. Chief Jackson excepted the exhibit and it was entered into the record.

Mr. Stolz gave the factual summary on the details leading up to the revocation. Mr. Stolz asked that the Council except the relinquishment and recommends that Mr. McKnight's Law Enforcement certificate, Supervisory certificate and Management certificate be revoked.

MOTION

Chief Wolf: I make the motion to accept the voluntary surrender of Stanley McKnight's Nebraska Law Enforcement certification, his Supervision certificate, and his Management certificate based on violation of State statute, violation of oath of office and violation of code of ethics. Chief Deputy London seconded the motion.

DISCUSSION

Asst. Chief Jackson asked if the motion to accept the voluntary surrender was the same as a revocation. Mr. Stolz stated that they were the same thing.

Asst. Chief Jackson commented that if we were going to be revoking certification of every officer who became upset with a person during the course of their duties it would extend the hours of the Council. Sgt. Bolzer asked if the incident had been investigated by a third party. Mr. Stolz answered that the Scottsbluff Police Department investigated. Mr. Stolz clarified that a voluntary surrender would be treated as a revocation.

Voting in favor: Deputy Chief Thomas, Chief Wolf, Asst. Chief Jackson, Sgt. Bolzer, Chief Deputy London, Sheriff Osmond. Motion approved.

B. Extension of 1 year requirement for Management Training

Martin McIntire, Holdrege Police Department

Director Urbanek presented the request for Martin McIntire to be granted an extension of the 1 year requirement for Management Training. Mr. Stolz provided the details of the online training for Management and what Chief McIntire failed to complete and his resolution for Chief McIntire to complete the course.

MOTION

Deputy Chief Thomas: I move that we extend the Holdrege Police Department Chief Martin McIntire, the one year requirement for Management Training. Chief Wolf seconded the motion.

Voting in favor: Chief Wolf, Asst. Chief Jackson, Sgt. Bolzer, Chief Deputy London, Sheriff Osmond, Deputy Chief Thomas. Motion approved.

C. Extension or 1 year requirement for Supervision Training

Taylor Samek, York County Sheriff's Office

Director Urbanek presented the request for Taylor Samek to be granted an extension of the 1 year requirement for Supervision Training.

Sheriff Osmond: I would make a motion that we grant the extension of the 1 year requirement to attend Supervision Training for Taylor Samek of the York County Sheriff's Office. Deputy Chief Thomas seconded the motion.
