Equipment Requirements

In the SIMUNITION® *Scenario Instructor and Safety Certification Course*, the goal is to train as close as possible to reality. Students should bring to the course operational equipment which he or she would normally wear; this should include a duty-belt or other personal tactical equipment including tac-lights, body armor and appropriate footwear. Live OC, Taser and impact weapons are not needed. The first day will be spent in the classroom in casual, comfortable attire. The final two days will be spent conducting Scenario-based training. It is during this time that the students will need his or her personal operational clothing and equipment.

SERVICE AMMUNITION IS NEITHER NECESSARY NOR PERMITTED AT ANY TRAINING SITE AT ANY TIME DURING THE COURSE!

Students should also bring seasonal outdoor clothing, outer garment for role playing, protective gloves, a ball cap, notebook and pen.

SIMUNITION® will provide pistol conversion kits as well as their associated equipment. SIMUNITION® will also provide basic protective equipment, all training ammunition as well as training aids such as training impact weapons.

If you choose to bring your own converted weapon(s) please see the outline below and your Instructor before the start of the course.

Utilization of Student Weapon Systems during FX® SIMUNITION® Scenario Instructor and Safety Certification Course

- 1) The student will be the only person to utilize his/her own converted weapon while training during scenarios. If they give consent for someone else to use their weapon, they do so at their own risk of damage to weapon.
- 2) The student will give his/her converted weapon to the Simunition® Instructors prior to the start of the training day or scenarios.
- 3) The Simunition® Instructors will maintain control of the converted weapons until the training day or scenarios have ended.
- 4) The Simunition® Instructor staff will act as TSO in preparing the weapon for the training day or scenarios.
- 5) The Simunition® Instructor staff will explain to the student that if anything may happen to the converted weapon, Simunition® is not responsible for replacing the weapon or the conversion kit.
